The form must be accompanied by the Certificate for Disposal. If not available at time of booking it must be received before the day of interment.

This form must delivered to the Clerk no later than two working days before the interment is due to take place (working days do not include Saturdays, Sundays and Bank holidays).

Ixworth & Ixworth Thorpe Parish Council will not be responsible for any misunderstanding regarding to orders or instructions given by telephone unless immediately confirmed in writing. A table of current fees and charges is available from the Clerk.

Please read the form carefully and ensure all information is correct before signing. Where arrangements are for the interment of cremated remains, please write C/R prior to entering the name of deceased.

A full copy of the rules of the Cemetery are available from the Clerk. It is advised that a minimum period of 6 months passes between the interment and the fixing of a headstone.

A further application if required for installation of a headstone.

Please note floral tributes will be removed from graves when the flowers have died unless the Council are advised in writing that the family wish to arrange for their removal.
